Information Leaflet



The Families Affected by Imprisonment Project is a partnership between Leicester City Council, Leicestershire County Council, Rutland County Council, Leicestershire Police, Schools, Probation and the Violence Reduction Network.

It was established in January 2021 to improve the support available to families who have a loved one in prison: we know that having a family member in custody is really tough for those on the outside and we want to make sure that families can get help and support during this time.

Information, support and guidance for those who have had someone close sent to prison

Support, information and guidance for families in Leicester, Leicestershire & Rutland.

Having someone close to you who is sent to prison can be a difficult time. We understand that everyone is different and affected in different ways.

You may feel that you don't need support at this time. These services can offer support at any point during the period of imprisonment and upon release.

If you are unsure, just call, support is available.

Local Early Help Services

Local Early Help Services can provide advice and information to families. This includes, if wanted, a family support worker should you need more dedicated support when adjusting to having a loved one in custody.
